

## **ENQUIRY REPORT**



DD(Admn),HSSPP,Panchkula vide UO No. Admn/SSA/2019/34741-43 dated 04.11.19(PUC) has requested to enquire the matter regarding embezzlement of Rs. 25,79,000/- by Smt. Munesh Chaudhary the then District Gender Coordinator,SSA,Faridabad and submit the enquiry report at the earliest. In order to enquire the matter, main file of case has been received from Administration branch,HSSPP,Panchkula and on the basis of documents/records as contained in main file, Brief facts of case are produced as under:

- Directorate of Secondary Education, Haryana vide their letter dated 11.06.2015 has requested to conduct the enquiry against Smt. Munesh Chaudhary, the then District Gender Coordinator, SSA, Faridabad against complaint lodged by Sh. Vikram Singh, S/o Sh. Desh Raj and submit the enquiry report to DSE Office for further necessary action.
- 2. As per Complaint, Complainant has stated that Smt. Munesh Chaudhary who was posted as District Gender Coordinator in SSA, Faridabad during 2003-2006 had taken huge illegal advances (in name of conduct various activities of SSA) in her personal Bank account with coordination of the then DPC,SSA,Faridabad Sh. R.C. Dahiya and embezzled Government money. The Rules/instructions of taking advance and mode of expenditure as per SSA Norms were totally avoid by her. As per Complaint, following advances were taken by Smt Munesh Chaudhary in the year 2005 and embezzled Govt, money as per following details:

As per records available in main file it was find out that in the year 2005, an enquiry was conducted against Sh. R.C. Dahiya, the then DEO cum DPC Faridabad regarding embezzlement of SSA Funds in which a committee was constituted consisting of Sh. B.L. Kapoor, Ex-CAO and Sh. Ombir Singh, Ex-SO, Karnal. In Enquiry Report, it was mentioned that the then DGC Smt. Munesh Chaudhary had committed following irregularities during her tenure in SSA, Faridabad:-

- Advances of Rs. 25,79,000/- had been given by the then DPC, SSA,Faridabad Sh. R.C. Dahiya
  to Smt. Munesh Chaudhary for various activities. Out of which Rs. 10,00,500/- from the
  NEPGEL Scheme inclusive of advance of Rs. 5,00,000/- has been given on 31.03.05 to District
  Gender Coordinator on simple demand. No accounts has been rendered by the DGC. It
  shows that the funds are being utilized with the consent of DPC. Such Heavy Advance could
  not be granted by the DPC as per delegation of powers at their own level (being competent
  to sanction Rs. 10,000/-).
- 2. Smt. Munesh Chaudhary had also hired taxi on various occasion @ 1100/- per day for about 85 kms without any approval of competent authority. As per HQ instructions, taxi may be hired for a pool consisting of Gender Coordinator, APC and ABRC. If three officers jointly going on tour on the same direction then taxi is to be hired. The approval of hiring of taxi is required from the ADC, Faridabad being a chairman of SSA. Hence the expenditure is irregular and contrary to the financial rules.

It is further stated that in May,2007, a complaint from Ch. Gajender Singh,District President, Haryana Rajkiya Adhyapak Sang-70, Faridabad had been received in this office in which Complainant alleged that Smt. Munesh Chaudhary,District Gender Coordinator who had been found guilty in the enquiry as stated above has been left without taking any disciplinary action against her. As per complaint, Smt. Munesh Chaudhary was granted advance amounting to Rs. 19,49,000/- and she has utilized the amount for her personal purposes and this amount was also not adjusted by DPC,SSA,Faridabad. Accordingly, Sh. Sanjay Joon,ADC cum Chairman,SSA,Faridabad was requested to investigate the matter and send the report along with specific comments for further order. ADC,Faridabad vide his reply dated 11.03.18 has stated that Complainant was requested to appear on 18.07.07 for investigation but he has submitted that he has not made any



complaint against DGC and some one used photocopy pad of union and signature on the complaint was fake. But to verify the charges Sh. Rajbeer Singh, Accounts Officer, Office of Distt. Rural Development Agency, Faridabad was deputed to check the whole records relating to complaint. As per enquiry report, following (indings/remarks were given by Sh. Rajbir Singh tabulated as under:

On the basis of enquiry report of Sh. Rajbeer Singh, the then ADC, Faridabad vide his letter dated 18.03.08 addressed to SPD Office had stated that as all advances granted to Smt. Muneesh Chaudhary have been adjusted by Smt. Anjala Nehra, the then DPC, SSA, Faridabad as per instruction issued by SPD Office and further confirmed by the then DPC, SSA, Faridabad Smt. Saroj Sharma that all advances were granted to DGC as per SSA Norms and also being adjusted as per guidelines issued by SPD Office, so compliant against Smt. Muneesh Chaudhary is not sustainable. On the basis of above report, case of complaint against Smt. Muneesh Chaudhary had been put up by Administration Branch, SSA Office to the then W/SPD, SSA vide which it was stated that on the basis of report submitted by Sh. Rajbeer Singh, AO and DPC, SSA, Faridabad compliant against Smt. Muneesh Chaudhary is not sustainable. Smt. Muneesh Chaudhary has been repatriated to her parent department and as charges against her have not been proved so no action is required to be taken further and the case is required to be closed with the order of W/SPD.

It is also stated that in order to enquire the above said matter, direction were also issued by this office to DPC, Samagra Shiksha, Faridabad to enquire the matter with outcomes of previous enquiry reports and submit the enquiry report with comments/findings against allegation as raised by complainant. But DPC Office, Faridabad vide their letter dated 20.06.19 has replied that at

present, no records/documents are available in their office pertains for the year 2005 & 2006 in ...ich advance were released to Smt. Muneesh Chaudhary and adjustment were made by DPC,Office, Faridabad. Due to previous enquiries, documents were earlier submitted to HQ and ADC Office, Faridabad. AO, Faridabad has also stated that at present, Smt. Muneesh Chaudhary is working as BEEO Faridabad and as stated by her no documents/records against allegation taised by complainant is also not available with her.

## Remarks of the committee:

As described in Enquiry Report of Sh. B.L. Kapoor, Ex-CAO and Sh. Ombir Singh, Ex-SO, Karnal relating to embezzlement of SSA Funds by the then DPC, Faridabad Sh. R.C. Dahiya that huge advances had been issued to DGC by Sh. R.C. Dahiya violating financial rules/norms of Parishad. As contained in financial rules/norms of SSA "temporary advance can be allowed to officers of subordinate offices or units, who have not been allowed to draw funds by cheques, by the Head of Office in order to make emergent payments of all kinds. As soon as the advance is utilized, account thereof together with complete supporting vouchers, shall be submitted to the HOO for adjustment and replenishment where necessary. Second Advance shall not be allowed unless account of first advance has been submitted to HOO by concerned official". No Prior sanction/approval was taken from the ADC cum Chairman, SSA, Faridabad before issuing such advances. The same statement was also pointed out in report against Sh. R.C. Dahiya which was duly signed by Sh. R.S. Gujral, the then FC and Principal Secretary, Govt. of Haryana, Education Department that-" Huge advances were issued to DGC without any justification. Before issuing the next advance, it was required to be ensured that the previous advances are cleared. For issue of such a huge amount of advances no sanction/approval was taken from ADC cum Chairman, Faridabad. Rs. 5,00,000/- were given to DGC on a simple demand, it shows that funds were misutilized with the convenience/consent of the District Project Coordinator. Such Heavy advances could not be granted by the DPC as per prescribed delegation of power" Besides, as per Enquiry Report of the then ADC cum Chairman, SSA, Faridabad which were conducted as per direction given by SPD office through. Sh. Rajbeer Singh, AO, DRDA in 2007-08. It was also pointed out by Sh. Rajbeer Singh, AO, DRDA that-

- 1. Smt. Muneesh Chaudhary,DGC has received Advance of Rs. 4,25,000/- for repair of Model Cluster Schools(MCS) @ Rs. 17,000/- for 25 schools. For which work of repair of class rooms has been executed from Private Contractor through collection of quotation. However as per rules/instructions of SSA, the work should be carried out through Village Construction Committee. It was also reported by AG(Audit) team that during test check of 25 MCS, it was find out that most of the schools are still under construction. So the expenditure of Rs. 17000/- per school on repair of schools is unjustified. The work of repair which is to be carried out by Village Construction Committee(VCC) was carried out without sanction from the competent authority.
- 2. Smt. Muneesh Chaudhary was granted an advance of Rs. 5,00,000/- as advance for research and evaluation work. The amount was drawn from bank on 21.04.05 and deposited back in SSA Bank. Account on 03.06.05 by DGC without execution of work. It was also pointed out in enquiry report of Sh. B.L. Kapoor that advance of Rs. 5,00,000/- was given to District Gender Coordinator by DPC on simple demand.

However, as per outcomes of enquiry report of Str. Rajbeer Singh, AO, DRDA under supervision of the then ADC, Faridabad against Smt. Muneesh Chaudhary it was stated that all advances granted to Smt. Muneesh Chaudhary for different activities have been adjusted by Smt. Anjala Nehra, the then DPC, SSA, Faridabad as per instruction issued by SPD Office on the basis of supporting documents submitted by Smt. Muneesh Chaudhary and it was also further confirmed by the then DPC, SSA, Faridabad Smt. Saroj Sharma that all advances were granted to DGC as per SSA Norms and also being adjusted as per guidelines issued by SPD Office.

In this regard it is stated that as per documents/records available in File of Smt. Muneesh Chaudhary provided by Administration Branch, SSA there were two enquiries (as detailed above) have been already done in previous years against Smt. Muneesh Chaudhary as against allegation raised by Complainants and at present no record pertains to the year 2005/2006 are available—at DPC Office, Faridabad in support of evidence/proof of releases of advances to Smt. Muneesh Chaudhary and invoices/bills/quotations/UCs submitted by her against such advances. It is further added that Currently, Smt. Muneesh Chaudhary—is working as BEEO,Faridabad and under control of Directorate of Secondary Education So it will be appropriate that Complaint—of misutilization of funds by Smt. Muneesh Chaudhary may be sent to Directorate of Secondary Education, Harvana for taking necessary action against Smt. Muneesh Chaudhary at their own level—on the basis of findings/comments as contained in previous enquiry reports.
